B. PRE-REQUISITE

There is a no-prerequisite course for taking the SL ABA Online Training Course. Participants should have a strong desire to learn the principles and practices of Applied Behavior Analysis. No part of the course is directed specifically at one target audience. Taking notes, asking questions for increased understanding, and putting the methods into practice are major components of the course.

C. STRUCTURE AND ORGANIZATION

Every multiple choice tests are graded automatically through our training system and you will receive results shortly upon submission. Once you have completed the final exam, your results will be evaluated by someone from our clinical team and your certificate of completion and CEU certificate/s (if applicable) will be issued and sent to you after completion of grading.

The content of the course was developed under the guidance of Board Certified Behavior Analysts (BCBAs) and other professionals with clinical ABA experience. As a result, this training is designed to support successful ABA programming in the home, center, school or community environments.

F. COURSE ACTIVITIES

1. STUDY MATERIALS: Most of the required study materials will be available for download from the Special Learning website prior to each session. If new materials are added, it will be made available during the course. It is best that you review the study materials prior to the session so that you will have



an easier time following along with the content. Participants will be provided with guided notes for each session. Guided notes are additional study tools designed to help increase retention.

Students are strongly encouraged to print out the guided notes and use it to take notes throughout each session for easy reference at a later time.

2. **PRE-TESTS:** Prior to each session, participants will be required to complete a 10-item multiple choice question pre-test. This test will be graded, but you are not required to pass the pre-test before you are granted access to the webcast. The pre-test is only used as a baseline for determining what level of pre-requisite knowledge participants have prior to taking the course.

We strongly advise you to answer the questions without referring to any reference materials.

3. **POST-TESTS:** Upon completion of each session, participants will need to complete a 20-item multiple choice question that is graded. Results will be sent within 24 hours of submission. The post-test will be graded using the standard ABA mastery criteria of 80% or above. Participants will NOT be able to move onto the next session until they have passed the post-test.

If a student does not pass the post test, they can review the information and re-take the exam as many times as required to achieve mastery. For the tests to have the greatest effect, we strongly encourage students to treat it like in-class quizzes. The post-tests are meant to give you a good idea of how well you are learning the material and are also aimed to reinforce learning.

4. **COURSE DURATION AND PACING:** Each participant will be given a maximum of 12 weeks to complete the course. That would give a participant at least one week to go through each of the 9 sessions and 3 weeks to review the study materials and prepare for the final exam.

Although we recommend setting aside 1 week for each session, participants can go through the course at their own pace, as long as they make sure that they are able to complete the course within the allotted 12-week period.

In case a participant does not complete the course within the 12-week period, he/she may request for an extension for a fee.

5. **COMPREHENSIVE COURSE ASSESSMENT:** At the conclusion of the ninth and final session, participants will be required to complete a comprehensive final exam to demonstrate their retention of the information contained in the entire course. Participants will have one week to complete and submit their answers to the 40-question test that also consists of multiple-choice questions. This assessment will incorporate select information from each module. Results will be graded using the standard 80-100% mastery criteria. Results will be sent automatically after submission.

To achieve the most accurate results, students are strongly encouraged to treat this like an in-class exam. If mastery criteria are not achieved, the participant will be allowed to retake the test multiple times until they demonstrate mastery. Successful completion of the course is a mandatory requirement for students to obtain their certification of completion.
